After pledge and roll call, Inboden welcomed all attending.

UNIT #2 DISTRICT UPDATES/ PUBLIC COMMENT:

Janna Surrells, CUTEA Co-Chairman, thanked the Board for all of the safety changes that have been incorporated at our schools. CUTEA is very much interested in helping the Board with further school safety endeavors. Superintendent Quick told the Board that a Safety Committee will be held on Monday, February 26 at 4:15pm to discuss safety issues. RHS Principal, Victoria McDonald, told the Board that a video is being prepared and will be shown to RHS students concerning the safety practices at RHS.

Kirk Rardin, LGS PE Teacher, spoke to the Board about the Hockey Program at Lincoln Grade School. The program is led by Ryan Reynolds, Reggie Truitt, Jared Wampler, and Kirk Rardin. Approximately 190 students participate in the hockey program at no cost to the child. Mr. Rardin then presented a video depicting some of the activities of the Hockey Program.


- **Extension of RHS Assistant Principal, Bob Coffman’s contract for July1, 2018 until June 30, 2020.**
