### CONSENT AGENDA

A motion was made by Bachelor and seconded by Stone to hire an Administrator to assist at NMS and with administrative oversight of District Athletics. Roll call vote: Yeas: Stone, Bachelor, Brown, Sandiford, and Inboden. Nays – none. Motion carried.

A motion was made by Sandiford and seconded by Brown to approve the date of April 23, 2019 as the date for a special meeting to seat newly elected board members and organize the Board. The meeting would start at 6pm. Roll call vote: Yeas: Bachelor, Stone, Brown, Sandiford, and Inboden. Nays: None. Motion carried.

- Food Service Application has been approved by the State. Bids will be sent out soon.

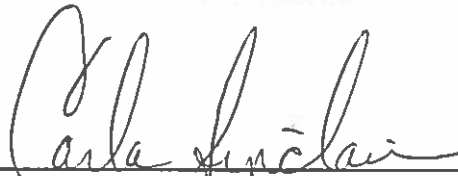
