WES Principal, Jason Stark, told the Board that the school year is winding down with final preparations being made. Teacher Appreciation Week went very well.


LGS Principal, Kathy Bemont, thanked all the teachers for a job well done.

NMS Principal, Craig Beals, told the Board that according to IESA rules student athletes can play up to 8 quarters per night and cross over grade levels.


