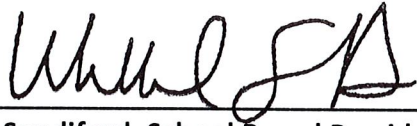
#### **SUPERINTENDENT’S REPORT:**

- WES library has been re-carpeted and new shelving installed.

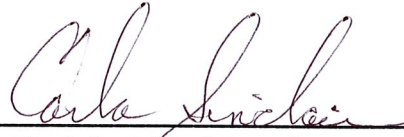
