VII.a. NMS Library - Report on 8th Grade Program

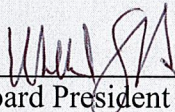

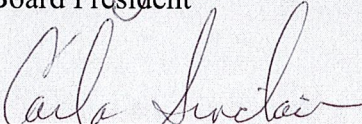
