VII.b. Buildings and Grounds Report

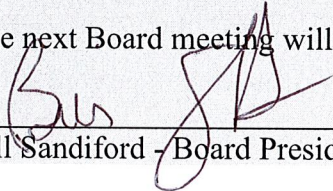
Superintendent Quick updated the Board on the following issues:
