

Press Release
May 16, 2011 Board Meeting

The following action was taken at last night's board meeting:

- Approved 2011/2012 registration renewal of IESA for LGS (\$75.00) and NMS (\$735.00)
- Treasurer Beard presented the amended 2011 budget. She noted the actual final numbers at the close of FY11 on June 30th will depend largely on whether Unit 2 receives any additional money owed by the State in time before that date. Regardless of state payments we should end the fiscal year slightly better than expected in the Ed. Fund and Transportation Fund. The board authorized displaying (at the Central Office) the 2011 amended budget for 30 days with adoption action to be taken after a public budget hearing at 6:45pm prior to the June 20th School Board meeting
- Approved the 2011 Meadows Scholarship Winners to be announced at Sr. Night tonight @ 7:00pm in RHS Gymnasium
- Authorized to begin preparation of 2012 CUSD #2 Budget
- Approved a resolution to allow transfer of total sum of traceable interest income from the Bond and Interest Repayment Funds of the district to the Education Fund of the district pursuant to the provision of Section 10-22.44 of the School Code of Illinois
- Approved a resolution to transfer \$2,560 from Debt Fund to Education Fund
- Approved Kemper CPA Group LLC as the 2011 CUSD #2 Auditor
- 1st reading of policy 5:185 with 2nd reading for approval at June 20, 2011 board meeting
- Expelled NMS student #215020 for the remainder of the 2010/2011 school year with said expulsion held in abeyance upon successful completion of a summer school program administered by NMS Administration
