CUSD #2 Press Release January 17, 2012

A Public Hearing regarding a Food Service Waiver was held at 6:45pm just prior to the board meeting last night. The waiver will exempt the district from providing a summer food service program. There were no questions or comments from the public.

Performance Services, Inc. Representatives Shana Lopez and John Robinson gave a power-point presentation on the energy savings @ Unit #2 over the last 24 months. They recognized Nuttall Middle School as one of the top 20 schools to receive the ENERGY STAR Plaque presented last night. Buildings receiving this award use 35% less energy and generate 35% fewer greenhouse gas emissions than similar buildings across the nation as well as NMS is now 62% more efficient based on utility bills for the reporting period of 2009-2011. They noted all Unit #2 buildings are becoming more energy efficient as well with the updates on boilers, roof replacement, hot water heaters, as well as other energy efficient equipment. Unit #2 joins an elite group of schools with less than 3% of Illinois K-12 schools having earned the distinction. A special thanks was given to Jeff Blair and Justin Rich for their efforts in helping Performance Services at NMS and other buildings as well with energy efficient procedures.
