

Press Release
May 21, 2012 Board Meeting

The following action was taken at last night's board meeting:

- Treasurer Beard presented the proposed amended 2012 budget. She noted the anticipated numbers at the close of FY12 on June 30th in the Education Fund were due to less revenue received over the year. The Transportation Fund was a little higher due to the fact that a bus was not purchased that had been in the budget. The board authorized displaying (at the Central Office) the 2012 proposed amended budget for 30 days with adoption action to be taken after a public budget hearing at 6:45pm at the June 25th School Board meeting
- Approved the 2012 Meadows Scholarship recipients as Peyton Phillippe and Paul Ackman
- Approved bid from Flat Rock Telephone Co-op for purchase of security cameras at Unit #2 schools
- Approved all Unit #2 schools 2012/2013 Student Handbook revisions as presented by NMS Assistant Principal Beals
- Approved Kemper CPA Group LLC as the 2012 CUSD #2 Auditor
- Expelled NMS student #216180 for the remainder of the 2011/2012 and the 2012/2013 school year with said expulsion held in abeyance upon successful completion of Alternative Education/Safe School Program. Bus expulsion for student #214147 as of April 26, 2012 to the end of the 2011/2012 school year.
